Section 4: Site Access Information

- Operating Hours for the Drury Managed Fill Operation are Monday to Thursday 7.00am to 4.45pm, Friday 7.00am to 3.45pm, Saturday 7.00am to 11.45am.
- Operating Hours for the Tuakau Sand Quarry Cleanfill Operation are Monday to Friday 7.30am to 5:00pm, Saturday 7.30am to 12:00pm.
- Quarry Rd, Drury is the preferred route when accessing and leaving Drury Quarry. Limit speed to 40kmh outside Ramarama School. It is preferred that trucks avoid passing Ramarama School between the hours of 8.00am – 9.00am and 2.30pm – 3.30pm Monday to Friday.
- No engine braking on Quarry, Fitzgerald or Ramarama Roads or within the quarry itself.
- The speed limit in the quarry, sand plant or fill site is 20kmh.
- Engine brakes must NOT be used:
Drury Quarry:
 In the Quarry Zone
 Quarry Road or Fitzgerald or Ramarama Roads

Tuakau Sand Quarry:
 On Friedlander Road
 Within 500m of the intersection of Friedlander and Buckland Roads
- Do NOT slam tailgates.
- Use of Wheel Wash is compulsory when exiting Drury and Tuakau Quarries.
- Dusty loads should be covered to avoid dust nuisance.
- Under no circumstances are you to be walking around operational vehicles.
- PPE required before exiting cab within quarry and fill sites: Hard Hat, Safety Glasses, Gloves, Long Sleeved Shirt, Long Pants and High Viz.

Section 5: Stevenson Terms for use of Fill Operations

The Account Holder is responsible and liable for

- Ensuring that all fill material disposed of at this site is within the criteria/limits outlined in the information provided
- That all information provided to Stevenson is true and accurate
- That at all times the directions of Stevenson will be followed.
- Any fill material deposited at Stevenson sites that do not meet the criteria or is deemed unacceptable and is rejected by Stevenson (at its sole discretion and at any time) will be removed and the Account Holder accepts liability for all costs associated with removal of fill material from the Stevenson sites, including any testing required, and all direct and consequential or indirect costs that Stevenson may incur.
- Stevenson reserve the right to suspend the Fill operations at any time for any duration and Stevenson do not accept any liability for costs associated with the closure.
- The Account Holder further agrees to fully cooperate with Stevenson if there is any further information or assistance required in relation to the fill material deposited.
- Stevenson is not liable to the Account Holder in anyway if the fill material is rejected or needs to be removed from the Stevenson site for any reason.
